- (1) Dismissible with \$20.00 fee provided remedied no later than the 20th working day after the date of offense and court is provided proof.
- (2) Dismissible with \$20.00 fee provided defect is remedied no later than the 20th working day of offense or before a first court appearance, whichever is later, and the court is provided with proof. Expired registration also requires that penalty fee is paid. Applies to expired inspection if the certificate had not been expired for more than 60 days. The sale of the vehicle does not dismiss the citation.
- (3) Dismissed with \$20.00 provided defect is remedied before first court appearance and court is provided with proof. Copy of invoice and picture of the working item required.
- (4) Dismissible with \$20.00 provided driver's license is produced that was valid on date of citation for the time violation was received, this must accompany a DPS letter showing that license is valid 20th working day of offense.
- (5) Dismissible upon verification of evidence that insurance was in effect on the vehicle driven at the date and time of the offense.

MUNICIPAL COURT NOTICE

This letter is furnished as a courtesy to you by the Municipal Court of Wells, Texas, to assist you in processing the charge(s) against you.

NOTE: The Judge cannot discuss the merits of a pending judicial proceeding prior to trial (Canon 6(c)(2) Code of Judicial Conduct). This means the Judge cannot discuss your citation/ticket with you before the trial. The municipal court clerk cannot discuss your plea or any other questions about your citation. They are only there to give you the amount that you need to pay.

INSTRUCTIONS

1. Contact the court by the due date written at the bottom of your citation. This is not a court date; you need to contact the court clerk via phone, in person or by filling out and mailing this completed form to the court; if you want to do a program you must call the court.
2. Failure to contact the court will result in a FTA charge and your license being reported to the TxDPS OMNI FTA website.
3. For a receipt let the court know to email it or send a self-addressed stamped envelope.
4. Allow the postal service 7-10 business days to deliver your packet to the court.
5. Always contact the court to verify that we have received your packet, and that your citation is closed.
6. Always make copies of everything that you send to the court.

PLEA SHEET (REVERSE SIDE) INSTRUCTIONS

If you wish to **ENTER A PLEA OF GUILTY OR NOLO CONTENDERE** please indicate by checking #1 or #2 on the reverse side of this plea form. A plea of Nolo Contendere means that you do not contest the state's charge(s) against you. The fine and conviction for a Nolo Contendere plea are the same as that for a plea of Guilty. Either plea indicates that you agree to waive appearance before the Court for trial.

Refer to the schedule shown on the reverse side to determine the total amount of fine (s) and costs acceptable by the Court. (These fines apply only to cases handled prior to Court trial or Judgment being entered.) **These fines don't reflect fees for construction or school zone violations.** Contact the court for balance due.

If you wish to enter a plea of **NOT GUILTY** and desire a trial, advise the Court by checking #3 or #4 on the plea form on or before the appearance date.

You will be notified by the Court when to appear for trial and specific requirements of the particular Court concerning bail requirements, etc. The judge has approved his court clerk to give you his citation offers. You may discuss these offers with the clerk.

If you should change your mailing address prior to receiving a notice to appear in court for your trial, it is your responsibility to notify the Court in writing of your new mailing address. This court will mail your pre-trial notice to the address provided to the officer at the time of your citation. We will assume that you have received your notice since this is the address you provided for your citation.

ANYONE RECEIVING A CITATION IN A CONSTRUCTION ZONE WITH WORKERS PRESENT OR HOLD A CDL LICENSE IS NOT ELIGIBLE FOR DEFENSIVE DRIVING OR REGULAR DEFERRED ADJUDICATION. PER TEXAS TRANSPORTATION CODE SECTION 472.022

DRIVING SAFETY COURSE AS A CONDITION OF DEFERRED DISPOSITION:

Please indicate by checking # 5 on the reverse side of this plea form. Under the laws of the State of Texas, you may be able to require that this (one) charge be dismissed by successfully completing a Driving Safety Course. **However, you will lose that right if you do not provide written a notice and a plea of Guilty or Noto Contendere to the Court on or before the appearance date (as shown on your citation).** Read all requirement in the box under # 5. Driver's safety courses only cover the speeding portion of your citation. You are required to pay all other portions of the citation. **You must first contact the court to verify that you're eligible for defensive driving.**

Texas license holders that fail to contact the court to respond to the charge(s) by the appearance date shown on the bottom of the citation/ticket, additional charge may be filed against you for violate promise to appear/failure to appear and warrants issued for your arrest.

Out of State license holders that fail to contact the court to respond to the charge(s) by the appearance date shown on the bottom of the citation/ticket, additional charge may be filed against you for violate promise to appear/failure to appear and warrants issued for your arrest under the Non-Resident Violator Compact (NRVC).

Additions charges of \$30.00 OMNI fee, 30% Collection fee; \$25 Texas Late Fee & a \$50 Capias Pro-fine Warrant fees will be added to each charge for executing or processing a warrant.

AT NO TIME IS IT THE COURT RESPONSIBILITY TO MAKE SURE YOUR CITATION IS TAKEN CARE OF; IT IS SOLE RESPONSIBILITY OF THE DEFENDANTS TO VERIFY THAT THE COURT HAS RECEIVED YOUR MAILED & EMAILED CORRESPONDENCE.
